2. **APPROVAL FOR MEMBERSHIP.** The facilities of the Club are owned and operated by The New Albany Country Club Corporation, an Ohio corporation doing business as New Albany Country Club. The undersigned hereby applies for a Club membership. This Application for Membership Privileges will not be acted upon unless fully completed and signed. Membership is contingent upon approval, which shall be in the Club's sole and absolute discretion. Applicants who submit completed and signed applications will be notified by the Club of its decision.

3. PAYMENT OF MEMBERSHIP INITIATION AMOUNT. The undersigned hereby applies for a membership in the Club and agrees to pay to the Club a required membership initiation of \$ _____ +tax (“Total Initiation Amount”). The initial payment is \$ _____, which the undersigned agrees to pay within thirty (30) days of the date the Club provides written notice of its acceptance of this Application. The remainder of the Total Initiation Amount shall be paid as follows: _____. Of the Total Initiation Amount, \$ _____ shall be refundable deposit (“Refundable Deposit”) and \$ _____ is non-refundable (“Non-Refundable Fee”).

4. SUSPENSION AND TERMINATION. The undersigned hereby acknowledges that the Club reserves the right, in its sole discretion, to suspend or terminate the membership for Member’s failure to comply with Club rules. Suspension and/or Termination does not nullify financial responsibility.

5. NONTRANSFERABLE. The undersigned acknowledges and agrees that personal memberships are not transferable except a Membership may be transferred to a spouse upon death, divorce, or one time during the life of a Membership to a son or daughter, upon approval by the Club.

6. RECALLING OF MEMBERSHIPS. The undersigned understands and agrees that the Club shall have the right to recall Non-Resident memberships no less than five (5) years following their issuance. In the event that a Non-Resident membership is recalled, the Club shall return the Refundable Deposit amount within thirty (30) days of the date the membership was recalled except any money owed by the member will be deducted from the amount to be returned. Nothing in this section shall impact the Club’s right to suspend or terminate any membership issued by the Club due to the conduct of a member, the member’s immediate family or the member’s guest found by the Club to be in violation of Club rules or regulations.

7. REPAYMENT OF MEMBERSHIP DEPOSIT FOR CLUB MEMBERSHIPS. The undersigned hereby agrees that upon the resignation or termination of the membership and the earlier of: (i) thirty (30) days after reissuance of the Club Membership or (ii) thirty (30) years from the date of acceptance of this Application for Membership Privileges as more specifically set forth in the Plan for the Offering of Club Memberships in the New Albany Country Club dated February 2013 (“Membership Plan”), the Club will unconditionally repay to the undersigned the Refundable Deposit without interest.

8. RECEIPT OF MEMBERSHIP PLAN. The undersigned hereby acknowledges and agrees to the terms of the Membership Plan. The undersigned further acknowledges that the membership is governed by the Membership Plan, the terms of which are incorporated herein by reference, and agrees to be bound by the terms and conditions thereof as amended, from time to time, in the sole discretion of the Club. Membership privileges may be suspended or terminated for failure to abide by membership conditions.

9. PREVENTING GOLF COMPACTION. The Club reserves the right to enact a temporary period of “Compaction Easement.” During this period, only one tee time will be made available per each golf membership. All active Members on the golf membership will have the same golf privileges other than during the times when the Club deems the easement of playability necessary. This practice enables the Club to better control the rate of play, preventing compaction during a peak period of play.



10. MEMBERSHIP PRIVILEGES IN THE CLUB. The undersigned hereby acknowledges that the Club Facilities are owned and operated by the Club and its affiliates and that a membership in the Club permits the member to use the Club Facilities, but does not constitute an investment in the Club or the Club Facilities. Membership in the Club does not give a member a vested or prescriptive right or easement to use the Club Facilities, but grants to the member a revocable license to use the Club Facilities. Members have no interest in the income of the Club and will not have the right to any of the Club's assets under any circumstance, including if the Club is dissolved. The undersigned further acknowledges that the Club reserves the right, from time to time, to reserve memberships for future purchasers of property in New Albany, to terminate memberships in the Club, to terminate or modify the Membership Plan, to discontinue operation of any and all of the Club Facilities, to sell or otherwise dispose of the Club Facilities and to convert the Club to an equity, member-owned club. The undersigned understands that a member has no right to vote or to otherwise become involved in the management of the Club. The payment of the membership deposit, membership fee, dues, club fees, state taxes, service charges, personal and other charges as the Club may establish from time to time is required to acquire and maintain membership privileges. With the exception of these membership charges, members are not subject to any liability or assessment for the costs and expenses of ownership or management of the Club or the Club Facilities.

Upon signing this Application for Membership Privileges, the undersigned authorizes the disclosure and release of information to New Albany Country Club for investigating the undersigned's qualification for membership and authorizes those persons or entities herein to furnish information to New Albany Country Club.

The undersigned understands that acceptance for membership at New Albany Country Club is subject to approval by New Albany Country Club and payment of the applicable membership deposit/fee, dues, clubhouse minimums and other charges as may be charged from time to time. All such charges and fees are subject to change at the sole discretion of the Club.
